Item, I freely give & dispose, all other my worldly Estate as well moveables as imoveables, both wth in doores & wthout, togeather wth all manner of debts, Sume or Sumes of money, any wayes due to me in Law or Equity, to Deborah my wellbeloved Wife, and Lastly I doe hereby freely Constitute, make & ordein my wellbeloved Wife Deborah, my Sole & Onely Exex, of this my last Will & Testamt, And I doe hereby utterly disallow, revoak, & disanull, all & every other former Testamts, Wills, Legacies, Requests & Exrs, by me, in any way before, this tyme, names Willed & bequeathed, Rattifieing & Confirming, this and noe other, to be my last Will & Testamt.
